These meetings are to gain a better understanding of local issues and concerns and, where applicable, to discuss possible mitigation.

## Issue identification (agenda item 4)

To get the most out of the time available during the forum, it has been suggested that we consider dedicating part of the meeting to break-out groups that can consider issues in more detail and report back to the forum as a whole. The suggested agenda adopts this approach.

The following are suggested areas taken from the note of the last meeting and/or suggestions received from forum members.

- Impact on properties
- Construction arrangements
- Noise impacts
- Road realignments
- Rights of way

The last two are areas suggested by HS2 Ltd, as these relate to work being undertaken on scheme design. This will be explained in more detail under agenda item 3.

At the forum members would be asked to agree the areas they wish to discuss in more detail, and attendees can form groups to consider these. Members would be free to decide which groups they participate in, and could move between multiple groups in which they have an interest.

Notes would be taken of each group's discussions, and representatives from HS2 Ltd would be available to answer group members' questions, and assist where required.
