By using slots/or gaps in the structure, pressure waves can dissipate and the 'boom' effect attenuated . The details of the portals are still being worked up, but current thinking suggests they are going to be approximately 100m long and will widen to a larger width than the nominal tunnel bore to help dissipate the pressure waves. Where feasible they will be incorporated within the existing tunnel length shown, but this would be subject to adjacent ground profile or features and more detailed design.
